## LECTURERS & OTHER FACULTY



**BRIAN BARTELL**  
*Lecturer in English*

Bartell joins the division as a lecturer in English for the fall and winter terms. He studies twentieth and twenty-first century American and Black studies with a special interest in technology, race and social difference, aesthetics, ecology, and political economy. His first book, *On the Eve of the Cybercultural Revolution: Black Power and Capitalism in the 1960s*, will be out this October. Bartell holds a PhD in English and comparative literature from Columbia University.



**SUSAN JUSTER**  
*Lecturer in History*

Juster is the W.M. Keck Foundation Director of Research at The Huntington. Prior to joining The Huntington, she was the Rhys Isaac Collegiate Professor of History at the University of Michigan, where she also served as associate dean for social sciences. A recipient of a 2020 Guggenheim Fellowship, Juster is the author of numerous books on the religious history of the early English Atlantic. She joins HSS this fall to teach a new course, Religion in America, from the Reformation to the Rapture (Hum/H 47).



**RICARDO MATTHEWS**  
*Lecturer in English*

A medievalist by training, Matthews studies historical rhetoric (medieval and premodern) and its relationship to romance. He will teach two courses at Caltech this year: Medieval Networks (Hum/En 56) and Medieval Hybridity (En 180). Matthews also teaches at his alma mater, UC Irvine, where he earned a PhD in English literature.

## LECTURERS & OTHER FACULTY



**JASON STOHLER**  
*Lecturer in History*

With a PhD in history from UC Santa Barbara (UCSB), Stohler's research interests include Chinese migration, US history, comparative gender, and law and society. He previously taught at The City College of New York and UCSB and will teach a course on Asian American history (H 161) at Caltech this winter.



**LISE VESTERLUND**  
*Moore Distinguished Scholar*

Vesterlund is the Andrew W. Mellon Professor of Economics at the University of Pittsburgh and director of the Behavioral Economics Design Initiative and the Pittsburgh Experimental Economics Laboratory. Her work in behavioral and experimental economics shows how gender differences in competition, confidence, and expectations contribute to the persistent gender gap in advancement. Her co-authored book *The No Club: Putting a Stop to Women's Dead-End Work* uncovers that a fair distribution of work assignments is the path to gender equity in the workplace. Vesterlund will visit HSS in spring 2026.



**CHRISTIN ZURBACH**  
*Lecturer in History*

Zurbach is a sociopolitical historian of medicine and minorities. She holds a doctorate from the history department at UC Berkeley, where she received an Outstanding Graduate Student Instructor Award in 2023. Zurbach spent the last academic year as the inaugural Cedars-Sinai/Huntington Library Postdoctoral Fellow studying the professionalization of medicine in the Ottoman Empire. She joins HSS in the spring to teach a new course on gender and sexuality in the Middle East (H 161).

## POSTDOCTORAL SCHOLARS



**KATHERINE CAVANAUGH**  
*Postdoctoral Scholar Research Associate in Climate Impacts*

Cavanaugh, who received a PhD in geography from UCLA, joined HSS to collaborate with Assistant Professor of Economics Hannah Druckenmiller. Her project focuses on quantifying the costs of sea level rise under various scenarios by combining geospatial data on human and natural systems with location-specific asset valuations. Cavanaugh aims to develop cost estimates at global scale and at high enough spatial granularity to inform local-level decision-making.

# POSTDOCTORAL SCHOLARS



## **RAQUEL CENTENO**

*Postdoctoral Scholar Teaching Fellow in Science, Society, and Policy*

Centeno's research is centered around the areas of public opinion, political psychology, and political behavior. She studies how voters think and feel about parties and partisanship, and she explores how these feelings are shaped by voters' various group identities, particularly their racial and ethnic identity. Centeno, who recently earned her PhD from USC in political science and international relations, joined HSS to collaborate with faculty in The Ronald and Maxine Linde Center for Science, Society, and Policy (LCSSP).

## **NICK EARHART**

*Weisman Postdoctoral Scholar Teaching Fellow in English and Visual Culture*

Earhart is a writer and researcher focusing on art, ecology, and urban space. He holds a PhD in English and a certificate in visual studies from USC, and his dissertation looked at the relationship between art and activism along the Los Angeles River since the 1970s. His 2025–2026 courses include Climate Fiction (Hum/En 42), Graphic Non-Fiction: Memoir, History, and Journalism (En/VC 198), and Nature Writing (Hum/En 42).

## **MATEUSZ FALKOWSKI**

*Howard E. and Susanne C. Jessen Postdoctoral Scholar Teaching Fellow in Early Modern Literature and the Classical Tradition*

Falkowski is a scholar of early modern Europe, studying intellectual and religious history with a particular focus on Italy and Spain. His work combines approaches from book history, classical reception studies, and the history of science. With a PhD in history from Princeton University, Falkowski was the 2024–2025 Francesco De Dombrowski Postdoctoral Fellow at I Tatti - The Harvard University Center for Italian Renaissance Studies in Florence. At Caltech, he will teach courses on Books, Readers, and Science in Early Modern Europe (H 113) and Environment and Environmental Expertise in Premodern World (Hum/H 16).

## **MAHMOUD JALLOH**

*Postdoctoral Scholar Research Associate in History and Philosophy of Science*

Jalloh joins the Einstein Papers Project to work with Einstein's published and unpublished writings, calculations, and letters ranging from 1930–1933. He comes to Caltech after completing his PhD in philosophy at USC and two years of teaching at St. John's College in New Mexico. Jalloh's research interests include the history and philosophy of science, particularly physics and metaphysics, as well as the history of philosophy, with a focus on Immanuel Kant, Ludwig Wittgenstein, and phenomenology.

## DELANIE J. LINDEN

*Anne Rothenberg Postdoctoral Scholar Teaching Fellow in Visual Culture*

Linden recently earned her PhD in art history from MIT's History, Theory and Criticism of Architecture and Art program. Her work is broadly concerned with the global trade of material culture as well as art and architecture materials imported into Europe and how these objects and resources influenced taste, local materials science, art techniques, architectural interiors, decorative arts and design, optical perception, and political economies in the nineteenth century. Linden will teach two courses this year: Color (Hum/VC 52) and Extraction! Art, Architecture, and Environmental History (VC 178).

*Administrative Assistant*

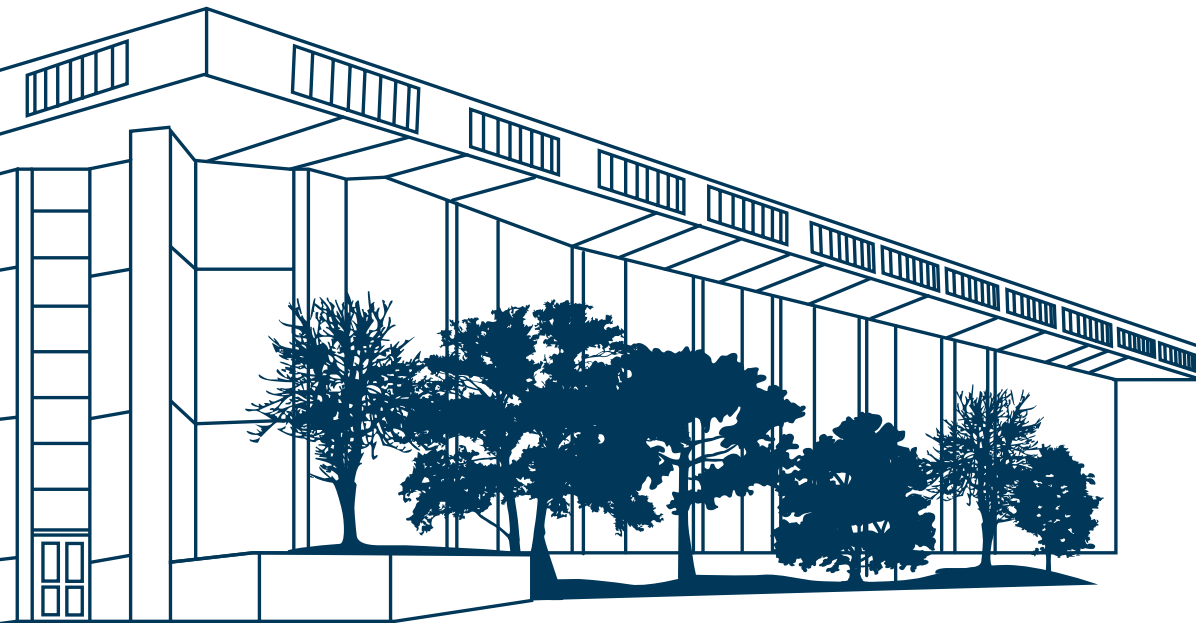
